# 2004.51 Mitchell Shackleton & Company Limited

Company History:

Company Hi 1887	Ernest Mitchell, former smith at Nasmyth Wilson & Co, establishes a forge at Bank Hall, Patricroft, forging ornamental iron railings.
c.1900	Mitchell is joined by a partner, Edwin Shackleton, and Mitchell, Shackleton is formed.
1907	Private Limited Company is formed, with Mitchell as Chair, and Shackleton, Kenneth Prescot and Thomas Pilling as Directors. Pilling resigns six weeks later when his firm is appointed as Company Auditors. Works are moved from Bank Hall to Green Lane, Patricroft.
1910	Mitchell designs the first crankshaft pinning machine, which facilitates improvements in accuracy while pins are machined on the crankshaft.
1927	Forge building is expanded.
1935	Machine Shop is expanded.
1936	Mitchell's son, Joseph, joins the company as a Director. Company is floated on the Stock Exchange as a Public Limited Company.
1940	Ernest Mitchell dies. Shackleton becomes Company Chair, Joseph Mitchell becomes Managing Director.
1947	Edwin Shackleton dies. Joseph Mitchell becomes Company Chair. Clarke's Crank & Forge Co Ltd of Lincoln acquired. Mitchell, Shackleton become sole supplier of crankshafts to Blackstone & Co Ltd.
1951	New Rough Machining Shop is built.
1958	The UK's first GFM Crankshaft Profile Milling Machine is housed in the Rough Machining Shop. Joseph Mitchell and Sales Director Bill Alexander travel to New York to meet Oscar Moncrief Stanley and establish trading links with companies such as Ingersoll Rand, Cooper and Worthington, the world's leading Reciprocating Gas Compressor manufacturers.
1959	John Thom Ltd's premises are purchased.

- 1960 All Issued Share Capital of H Fordsmith Ltd is acquired.
- c.1962 Machined crankshaft is supplied to Clark Brothers Inc. of Olean, USA.
- Mitchell, Shackleton & Co Ltd take over Walter Somers Ltd, changing the company name to Mitchell Somers Ltd with the creation of a Holding Company.
   Patricroft works continue to trade as a new company under the original name Mitchell, Shackleton & Co Ltd.
   Joseph Mitchell is manager of Mitchell Somers, and therefore not a Director of Mitchell, Shackleton & Co Ltd.
- 1964 Forging operations are ended at the Patricroft works.
- 1966 Heavy Finish Machining Shop is opened in 1966.
- 1969 Joseph Mitchell retires.
- 1984 Mitchell, Shackleton & Co Ltd is sold by Mitchell Somers PLC to National Forge Company of Irvine, Pennsylvania, USA.
