The papers of Davis, George Edward (1850-1907)/G.E. Davis and Davis Bros., Manchester.

Includes testimonials, correspondence, legal agreements and advertisements relating to Davis's firms of Davis's Chlorine Processes Ltd. and Davis Bros and to his connection with the Alkali Inspectorate, the Society of Chemical Industry and the Sulphate of Ammonia Manufacturers. There are also some papers on the Chemical Trade Journal which Davis founded and some family correspondence.

In 1878 having had a varied 10 years of experience in the chemical industry, Davis was appointed a sub-inspector to the Alkali Industry. He resigned from the Alkali Inspectorate in 1883 and went to work at Messrs. Newton Chambers' gasworks at Rockingham. During this time he was also acting as a chemical consultant and it was this business which prompted him to leave Rockingham in 1886. One year later Davis published the first edition of the Chemical Trade Journal and in 1890 formed a partnership with his brother Alfred R. Davis to continue the consultancy work and pUblication of the Journal. The two brothers also formed a company Davis's Chlorine Processes Ltd. in Lostock Gralam in 1890. Davis is perhaps best remembered for the publication of the Handbook of Chemical Engineering in 1904.

The papers of G.E. Davis were purchased from J & L Spake of Dawlish in 1984.
